

# DEPARTMENT OF SOCIAL PROTECTION ANNUAL PROTECTED DISCLOSURES REPORT 2022

## **Protected Disclosures Act 2014 as amended by the Protected Disclosures (Amendment) Act 2022**

The Department is committed to fostering an appropriate environment for addressing concerns relating to potential wrongdoing in the workplace and to providing the necessary support for staff that raise genuine concerns. The Act requires public bodies to establish and maintain reporting channels and procedures for dealing with protected disclosures and to provide written information relating to these procedures to workers. The Department has internal reporting channels and such procedures in place, details of which are published on gov.ie.

Four submissions were made in 2022 to the Department under the Protected Disclosures Act 2014 (as amended by the Protected Disclosures (Amendment) Act 2022).
