

Notice of Intention to Grant a Prospecting Licence

Since it appears to the Minister for the Environment, Climate and Communications (the Minister) that there are minerals not being worked under the lands in the areas set out below, pursuant to section 7(1) of the Minerals Development Act 1940, as amended, the Minister intends to grant a prospecting licence for **Lithium, Rubidium, Caesium, Base Metals, Silver (Ores of), Gold (Ores of), Rare Earth Elements, Beryllium and Platinum Group Metals** to **Arkle Resources Plc, 162 Clontarf Road, Dublin, D03 F6Y0**, over the following Townlands in **Wexford and Wicklow**:

The Minister reserves the right to make details of the submissions available to the applicant in order to fully consider their validity.

NB: A Prospecting Licence entitles the holder to explore for mineral deposits and **does not authorise mining of any minerals**. The activities permissible under a licence are, in general, non-invasive and of minimal environmental impact. The Minister has assessed the exploration programme proposed by the Company and has determined that the activities are not likely to have a significant effect on the environment.
