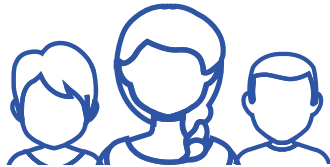

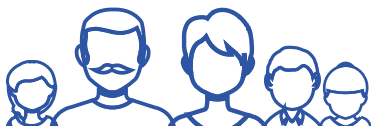

They will benefit from

*Working Family Payment threshold will increase by €54 per week in 2024 regardless of family size.

WFP is 60% of the difference between the income limit for family size and assessable income.

They currently receive a weekly rate of €503.10 (€265.30 + €237.80) and a seasonal Fuel Allowance of €33 per week.

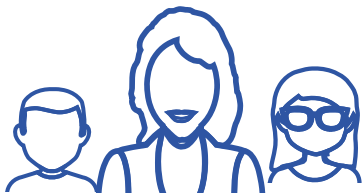

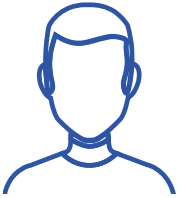
