8 Consultation questions:

- The Report recommends a centralised, operational model for Ireland. Do you agree with this recommendation? Yes
- If not, do you favour a:
 - a) decentralised / financial DRS; or,
 - b) hybrid.

Are there other models you believe could work in an Irish context?

- What role should waste collectors play in the operation of a DRS? they should change guidelines for their recycling collation to inform about plastic bottles and cans to be subjected to DRS;
- The DRS study proposes a deposit per container of €0.20. Do you think this is appropriate? If
 not should it be higher or lower or should different deposit rates apply depending on
 container size? should be higher, like €0.50 or even €1. Should be flat, keep it simple.
- Consumers need to know about a DRS long before it becomes operational do you have any suggestions as to how best the introduction of a DRS can be communicated to the public? – leaflets, television and social media campaign would do
- What enforcement measures should be considered in parallel with the introduction of a
 DRS? Measures that will prevent producers/distributors to switch to non-recyclable or
 Non-DRS Complaint containers. Non-DRS compliant containers should be taxed/levied etc.
- How should cross-border issues be treated to ensure producers are not at a competitive disadvantage relative to producers in Northern Ireland? – Every container introduced to Irish (Republic) market should to be "taxed" with DRS. Doesn't matter where it has been made.

My own comments:

- 1. DRS relate to "producers" only as a source of plastic subjected to scheme. What about beverages that are imported and not produced within the state? They should be addressed and in the system as well.
- 2. Cashless system for returning deposit is great but I doesn't necessarily encourage trash pickers to make some cash by collecting litter and returning for small profit. I think there should be option for cash or debit card top up on the return.
- 3. Non-recyclable packaging: Producers and distributors might try to avoid DRS with slight change in their packaging to make them non-recyclable or non-DRS compliant (or switching to tetra pack as well). In my opinion every <u>disposable single-use plastics should be heavily taxed or subjected to DRS</u> in order other technologies are introduced to the marked (biodegradable packaging etc.). So end the end we will have mostly:
 - a. Packaging subjected to DRS
 - b. Compostable packaging (paper, starches, cellulose, fibres etc.)
- 4. Plastic TAX should be introduced in Ireland (and elsewhere). Taxing single use of plastics and also other plastics with level of taxation depending on recycled plastic content.
