


# Have Your Say on New Rules to Keep People Safe when They Use Care Services

## The government wants to hear what you think about its new plans.

They want to know if you think the plans are a good idea or a bad idea.

This is called a consultation.



This consultation is about plans for safeguarding.



### What is safeguarding?

Safeguarding means keeping you safe from harm.



#### We are asking you about new plans for keeping people safe when they use certain services.

These services are health and other care services.

This can include disability or mental health services, nursing homes, hospitals, or going to your doctor.



## We want your views about the new plans.

You can also say any changes you would like us to make or what you like about the plans.



#### **Our Vision is**

That you are kept safe from harm when you use health and other care services.

## Goal and purpose The new rules – Who and What are the new rules for?



The rules will help people aged 18 or older when they use health and other care services.

Some people are more **at risk**, which means they are in more danger of someone harming them.

The new rules will help keep these people safer.



The rules will support and respect your rights.



The rules will make sure that you can make your own choices.

The rules will make sure that staff and volunteers will work to keep you safe from harm in a way that does not upset you.



There will be new rules for staff and volunteers to keep you safe in health and other care services.

# Ways of Working How we will work with you



Giving information and training about keeping people safe.



Making sure services try to prevent harm from happening.



Protecting you from harm by making sure the rules are followed by everyone.



Making services and other organisations work better together to keep you safe from harm.

# Ways of Working How we will work with you continued



Bringing in new laws and rules to protect you.

### How we will work with you



We will "put you first".



We will help you make your own Choices.



We will accept you for who you are and for what you believe.

We will respect your rights.

### How we will work with you continued



We will be fair and respectful in how we work with you to keep you safe.



We will help services and other organisations to work together to protect you.



We will answer to you about how well we keep people safe.

#### The Government will make sure that:



Everyone must work to keep people safe from harm.



Special Health Service Executive (HSE) Teams called "Adult Safeguarding and Protection Teams" will still be based in all parts of Ireland.

These Teams will still work to keep people safe from harm.



The new rules say that the HSE will still lead all of this work.


