

Marine Notice No. 23 of 2024

Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

Corrib Gas Field Offshore Pipelines and Subsea Structure Inspection and Nearshore Survey

1. Notice of Activity

The Department of Transport has been advised by Vermilion Exploration & Production Ireland Limited of a maintenance campaign that will include an offshore pipeline and subsea structure inspection at the Corrib subsea infrastructure which is due to commence on **14 May 2024** and will last for approximately **30 days.** A nearshore survey of the pipeline and umbilical of the Corrib subsea infrastructure will also take place. These works are due to commence on **17 May 2024** and will last for approximately **10 days.** All work dates are subject to weather and operational constraints.

2. Location of Activity

The offshore pipeline and subsea structure inspection of the Corrib subsea infrastructure will take place at the below location. Visual and acoustic surveys will be conducted by means of vessel and Remote Operated Vehicle (ROV) mounted sensors. Electrical fault finding will be conducted by ROV mounted equipment.

The nearshore pipeline and umbilical sections will be inspected from the nearest point accessible inshore at high tide, progressing to offshore, until a suitable overlap with the offshore inspection is achieved. This location is provided in the table below. Visual and acoustic surveys will be conducted by means of vessel mounted sensors, cameras, ROV and towed Side Scan Sonar.

3. Details of Survey Vessels

The vessel "**EDT Jane**" (call sign: 5BXW3) will undertake the subsea scope of work as part of the offshore pipeline and subsea structure inspection. All equipment used will be vessel and/or ROV mounted.

The vessel "Leah C" (call sign: EIQS5), will undertake the near shore survey scope while the vessels "Macbel" (call sign: EIHL5) and the "Blue Eagle" (call sign: El6808) will both provide safety and welfare support to "Leah C".

The vessels will be listening on VHF CH 16 throughout the project.


