Application for a Dumping at Sea Permit

Notice is hereby given that Dublin Port Company has submitted an application to the Environmental Protection Agency for a permit under Section 5 of the Dumping at Sea Acts 1996 to 2010. The application is for the loading and dumping of dredged material arising from maintenance dredging proposed for 2020 and 2021. Dublin Port Company need to carry out regular maintenance dredging of the navigation channel, basins and berthing pockets in order to maintain their advertised charted depths and hence provide safe navigation for vessels to and from the Port. The loading of dredged material will be restricted to those areas of the navigation channel, basins and berthing pockets which contain sediments which are sultable for disposal at sea (Class 1: uncontaminated, no biological effects likely), it is proposed to dispose of the dredged sediments at the existing licensed offshore disposal site located at the entrance to Dublin Bay to the west of the Burford Bank, (6.75 km from the lighthouse at the end of the Great South Wall). The approximate amount of material to be dredged is 300,000 m3 per annum and it consists mostly of sili and sand with elements of clay, gravel and cobbles. Dredging will be carried out by a trailer suction hopper dredger and support vessels. It is proposed to undertake the maintenance dredging and disposal at sea operations within the period April to September 2020 and 2021. The dredging campaign within each of these periods is expected to last approximately 4-6 weeks, depending on weather conditions.

Notice of EIA Screening Determination

An application for consent to drill a single exploration well in the iolar prospect under Frontier Exploration Licence (FEL 3/18) in the Porcupine Basin offshore of the south west of Ireland was received by the Petroleum Affairs Division of the Department of Communications, Climate Action and Environment from CNOOC Petroleum Europe Limited (formerly known as Nexen Petroleum U.K. Limited), on 14th November 2018. The purpose of the exploratory well is to gather data on the reservoir characteristics, hydrocarbon presence, pressure and temperatures.

An EIA Screening Assessment of the application was carried out by the Environmental Advisory Unit of the Department pursuant to Regulation 3(1B) of the European Union (Environmental Impact Assessment) (Petroleum Exploration) Regulations 2013 (S.I. No 134/2013) as amended by the European Union (Environmental Impact Assessment) (Petroleum Exploration) (Amendment) Regulations 2019 (S.I. 124 of 2019) ('the EIA Petroleum Exploration Regulations'), taking into account the matters specified in Regulation 3(2A) of the EIA Petroleum Exploration Regulations, and in accordance with Article 4 of the Environmental Impact Assessment Directive (Directive 2011/92/EU, as amended by Directive 2014/52/EU).

An EIA Screening Determination has concluded, following screening, that the proposed drilling project is not likely to have a significant effect on the environment and, consequently, an Environmental Impact Assessment is not required in respect of the application. The Decision is contingent on the mitigation measures proposed by the Applicant being included as conditions in any drilling consent that may be granted by the Minister in respect of the application.
