1. Foreword

As Independent Chair to the Implementation Group, I am very pleased to present my first report to the Minister with special responsibility for Housing and Urban Development at the Department of Housing, Planning and Local Government and the Minister with special responsibility for Mental Health and Older People.

Since the establishment of the Group, I can confirm that there has been a very high degree of commitment by all those involved, and a real sense that this cross-departmental, multi-stakeholder approach is one that has energised people to work in a collaborative way on this important subject.

Each group reports on progress to the overall Implementation Group.

A feature of our work to date is that we have arranged to hear from people or groups with relevant expertise in areas relevant to our remit, either through the sub-Groups or at the overall Implementation Group. We will continue to do this over the coming year. This will help to ensure that we are as informed as possible as we pursue implementation of the actions in the policy statement.

There is no doubt that strong Ministerial support is crucial to achieve momentum and focus and to maintain the current cross-departmental, multi-stakeholder approach. It is vital that this level of support is sustained throughout 2020.

I would like to thank all the members of the Implementation Group and the sub-Groups for the commitment they have shown since our establishment. I would particularly like to thank the secretariat for the excellent work they are doing to support and enable the Group.

Finally, can I say that it was an honour to be asked to assume the role of Independent Chair, and I look forward working with all involved to accelerate progress throughout 2020. The passion of those working at both the frontline and at policy level to make a difference for those we collectively

serve is real, and I sincerely hope that this collaborative approach to implementation will enable them to make that difference in 2020.

2. Introduction

On 27 February 2019, the Joint Policy Statement "Housing Options for our Ageing Population" was launched by Mr. Damien English T.D., Minister for Housing and Urban Renewal with Mr. Jim Daly T.D., Minister for Mental Health and Older People.

The joint Policy Statement was developed by the Department of Housing, Planning and Local Government (DHPLG) and the Department of Health (DoH), with support from key stakeholders including the HSE, the Housing Agency and Age Friendly Ireland. The policy statement was also informed by stakeholder engagement events in November 2018 and February 2019.

The purpose of the Statement is to provide a policy framework to support our ageing population in a way that will increase the accommodation options available and give meaningful choice in how and where people choose to live as they age. The core aim is to increase the options available to older people and to facilitate the integration of supports in a more coherent way, particularly between the housing and health sectors, with a view to facilitating people to live at home and in their communities, independently, for longer. It identifies a programme of 40 strategic actions to further progress housing options for older people under the themes of data gathering, collaborative working, delivering choice, support services, comfort and safety and maintaining momentum.

3. Establishment of the Implementation Group

The Policy Statement set out that in order to deliver on the actions, an Interdepartmental/agency Implementation Group would be established, including membership from the two Departments, the Health Service Executive, Local Authorities and relevant stakeholders.

This Group is responsible for progressing the actions set out in this statement with a view to contributing towards the objective of supporting older people to live in their own homes and communities with dignity and independence for as long as possible and, in so doing, to progress the development of various housing options and improving the integration of services and inter-agency collaboration. Following the appointment of the Independent Chair in June 2019 by Ministers Jim Daly and Damien English and the establishment of the Implementation Group, the first meeting of the Group took place on the 10th September 2019. The Group of 22 consists of subject matter experts drawn from the following organisations:

- Department of Housing Planning and Local Government
- Department of Health
- Department of Rural and Community Development
- County and City Management Association
- The Housing Agency
- Age Friendly Ireland
- The Health Service Executive
- Irish Council for Social Housing
- Older People's Council

Following the first meeting of the Implementation Group, three Sub-groups were established and those sub-groups have the capacity to co-opt further members to ensure the correct expertise is available to the groups in any given area.

4. Methodology/ Governance

Mr. Damien English T.D., Minister for Housing and Urban Renewal and Mr. Jim Daly T.D., Minister for Mental Health and Older People appointed Mr. Leo Kearns as independent chair of the Implementation Group and with the chair and project sponsors approved the terms of reference of the Group (see Appendix 1).

The Implementation Group sponsored jointly by the Assistant Secretary with responsibility for Housing Policy, Governance and Legislation in the Department of Housing, Planning and Local Government (DHPLG) and the Assistant Secretary with responsibility for Social Care in the Department of Health (DoH).

The Chair has overall responsibility for providing leadership and coordinating the work of the Implementation Group. He will meet the Implementation Group sponsors biannually to report on progress, raise any issues and provide a general view on the progress of the work programme. He will report to the Minister with special responsibility for Housing and Urban Development at the Department of Housing, Planning and Local Government and the Minister with special responsibility for Mental Health and Older People at the Department of Health on a bi-annual basis.

The Implementation Group will assist both Departments in its implementation of the joint policy statement on Housing for Our Ageing Population. e Implementation Group is committed to operating in an open and transparent manner and includes the management of all real and potential conflicts of interest of members, and others involved in assisting in the implementation of the joint policy statement on Housing Options for Our Ageing Population. Similarly, DHPLG and DoH staff are bound by the Civil Service Code of Standards and Behaviour (2004) in the discharge of their duties, which includes avoiding conflicts of interest.

At the first meeting of the Implementation Group, which took place on Tuesday 10th of September 2019:

- draft Terms of Reference were agreed.
- the Chair advised that the role of the group was to ensure that there is an
 integrated approach to progressing the implementation of the 40 actions
 outlined in the policy statement and that the responsibility for the delivery of the
 actions lies with the Departments.
- the Chair confirmed that at the start of each meeting members of the Implementation Group would be provided with an opportunity to disclose whether they have a conflict of interest with any agenda item.
- it was agreed that the Implementation Group would meet 4 times a year.
- the Chair advised the Group that he would report to both Ministers bi-annually and prepare 3 reports for both with the first report, due in December 2019, providing a baseline.
- 3 sub-groups were established to examine specific actions from the policy statement under 3 work streams.
- it was agreed that each of the subgroups would report back to the
 Implementation Group and develop project initiation documents covering key
 actions/projects to be presented to the Group at its December 2019 meeting.
 Work on a number of other actions, by their nature, is being led by the
 Departments directly and will also feed into the work of the Implementation
 Group.

The 3 Workstreams (subgroups) established to support the work of the Implementation Group are:

1) Workstream 1

As noted, work on some actions is being led directly by the Departments rather than the Group but updates on progress will feed directly into the Group who will also be able to provide feedback and help to ensure an integrated and overarching approach for implementation.

5. Progress to December 2019

1) Research undertaken Health Research Board Housing with support for older people-An evidence brief ¹

This evidence brief aims to support the Department of Health and the Department of Housing, Planning and Local Government by describing approaches that OECD countries have taken to providing housing with support for older people and provide an outline of international evidence on the matter. Housing with support is defined in this brief as non-institutional accommodation for older people where support or care services are available. Based on literature sourced from twelve countries, two key approaches were identified: ageing in the family home (which can be facilitated by home adaptations or constructing secondary suites, often referred to as 'granny flats') and ageing in a community designed for older people. Among the latter, in this report we covered four key models: naturally occurring retirement communities, cohousing, apartments for life, and extra care housing. Naturally occurring retirement communities and co-housing communities are suited to those who are capable of living independently. Apartments for life and extra care housing encourage independence and social engagement, yet they also aim to provide a home until the end of life by facilitating home care as needs increase over time. Implementing a

range of models for housing with support would allow older people to choose which model suited their needs and preferences at different stages of their ageing. Key enablers of housing with support include innovative funding models, close coordination between health services and housing providers, the use of universal and social contact design, and nurturing a culture of volunteerism and peer support among older people. Crucially, housing with support can potentially reduce institutionalisation and increase quality of life for older people.

Phase 2 of this research project has commenced looking in greater depth at certain aspects of housing with support. The next phase is expected to be completed in Q2 2020.

Housing Agency - Thinking Ahead - The Financial Benefits of Investing in Supported Housing for Older People

The Housing Agency are progressing a paper which examines the costs and the benefits to the State of an expansion in the provision of Supported Housing for older people. The paper explores the costs of providing a range of Supported Housing options, grouped into three distinct stages: Independent, Assisted, and Specialised, in line with Stages 4-6 referred to in the 'Housing Options for an Ageing Population' Policy Statement. The paper compares the costs to the State of providing Supported Housing to a number of alternative scenarios where it is assumed that Supported Housing is not available.

The paper establishes that there is a strong positive financial benefit to the State from the provision of Supported Housing – Independent, Assisted and Specialised. Benefits accrue through reduced health and social care needs, along with a reduced requirement for more costly nursing home beds. It was further established that there are benefits from the provision of both a social model of supported housing and a privately funded model.

Mature Homeowner Survey

A research project, examining mature households' preferences in respect of housing, is underway. This delivers on a commitment made in Housing Options for an Aging

Population. The survey explored the housing circumstances and attitudes of households composed of homeowners aged 55+ with a view to generating policy relevant findings.

A focus of the survey was the attitude of mature homeowners toward seeking housing better suited to their circumstances (typically, trading down) or to relocate from areas of high demand to lower demand. Preliminary results were presented in November 2019, which indicated that most mature households have limited interest in downsizing, but that there are cohorts, which may be open to downsize under certain conditions. The overall size of the cohort that suggested they may be interested in the option of rightsizing if purpose built housing for rightsizing existed is circa 17.5%.

 A research paper analysing the findings of the survey will be prepared during Q1 2020.

Researcher

The Department of Health has recently recruited a research assistant to work with the Department over the coming 12-18 months on further research to assist with the further implementation and policy development with regard to the policy statement.

2) Subgroup 1 - Building and planning related aspects of housing with support

This subgroup has met on three occasions. The first meeting took place on the 26th of September in the Custom House, the second meeting took place on the 25th of October in the

3) Subgroup 2 - Health and social care aspects of supported housing

This subgroup has met on 2 occasions in the Department of Health, Baggot Street. At the first meeting which took place on 23 September a number of workstreams were agreed and assigned. The second meeting took place on 21 October.

The subgroup has considered a number of aspects of the actions assigned to it and discussed how those actions might be progressed. The subgroup intends to produce a master project initiation document (PID) which will set out key work and subactions that need to be put in place to deliver the relevant policy statement actions. Progress has been made across all actions and these are outlined in the table below.

- Representative from Department of Rural and Community Development (DRCD)
- Representatives from the Health Service Executive (HSE), to include:
 - Assistant National Directors for Older People Strategy and Operations (or their nominees)
 - Clinical representative
- Representative from County and City Management Association (CCMA)
- Representative from the Housing Agency
- Representative from Irish Council for Social Housing
- Representative of Approved Housing Bodies
- Representative from Alliance of Older People Sector NGOs
- Age Friendly Ireland representative
- Citizen Representatives from Older Peoples Councils (x2) (Total 20+)

As necessary and as appropriate attendance at meetings may also include a researcher provided via the Healthy and Positive Ageing Initiative (HaPAI), to undertake and assist with various research, evidence and policy analysis inputs, particularly with regard to supported housing models.

2. Purpose & Role

The purpose of this Implementation Group is to ensure that there is an integrated approach to progressing the implementation of the forty actions outlined in the policy statement. The Group will monitor, drive, and enable the delivery of the forty actions outlined in the Policy Statement.

3. Terms of Reference

- 3.1. Support and monitor the implementation of the forty actions outlined in the policy statement.
- 3.2. Compile a register of the action plan.
- 3.3. Ensure that, where relevant, actions are progressed in an integrated way between the housing and health and social care sectors.
- 3.4. In considering the actions, the Implementation Group will examine and take into account the policy implications arising, in order to develop a cohesive inter-Departmental policy on supported housing.
- 3.5. Explore, scope and provide analysis of policy inputs and proposals for a model/policy for supported housing to be further considered by the Departments.
- 3.6. May consult with relevant stakeholders from time to time to ensure views, issues and challenges for older people are represented and that information from the stake-holder groups is disseminated to the sector.
- 3.7. Publish six-monthly progress reports.

In respect of any new policy considerations arising from the work of the group, Departmental officials, will as necessary and appropriate, revert such matters for consideration via the relevant governance structures within Departments.

4. Implementation Group Governance

- 4.1. The Implementation Group sponsors are the relevant Assistant Secretaries from both Departments:
 - Paul Lemass, DHPLG
 - Kathleen MacLellan, DoH

4.2. Role of the Chair

The Chair will have responsibility for providing leadership and coordinating the work of the Implementation Group.

The Chair shall:

- Set and manage the agenda for each meeting to ensure the efficient use of time for each meeting
- Manage declarations of conflict of interest as they arise, according to the Implementation Group's conflict of interest policy.

- Encourage broad and effective participation from members.
- Conclude each meeting with a summary of decisions.
- Sign off meeting minutes once approved by the Implementation Group.
- Nominate an alternate should the Chair be unable to attend a meeting.
- Meet the Implementation Group sponsors biannually to report on progress, raise any issues and provide a general view on the progress work programme.
- Report to the Minister with special responsibility for Housing and Urban Development at the Department of Housing, Planning and Local Government and the Minister with special responsibility for Mental Health and Older People at the Department of Health on a bi-annual basis.

5. Terms of Engagement/Operational Arrangements

- 5.1. Implementation Group members are expected to participate within the Group in accordance with the Conflicts of Interest Policy.
- 5.2. The Chair will decide the schedule of meetings in consultation with the group.
 - 5.2.1. The group will meet a minimum of 4 times per annum
 - 5.2.2. During certain stages of the implementation of the actions, there may be a requirement to meet more regularly.
 - 5.2.3. Attendance is required by member at all meetings, and where this is not possible an alternate will attend in their place, agreed in advance with the Chair.
 - 5.2.4. Three sub-groups will be set up under the implementation group, members of these groups will meet twice before each Implementation Group meeting.
- 5.3. Both DHPLG and DoH will provide support and guidance where possible to the Implementation Group for their meetings.
- 5.4. A secretariat will be provided by XXXXX
- 5.5. The Chair, with the assistance of the Secretariat, will prepare a brief written progress report biannually for submission to the relevant Ministers.
