| | The proposed development would extend from the grounds of Malahide Demesne to the R106 Dublin Road, O'Hanlon's Lane and Bissets Strand in Malahide, cross Malahide Estuary, cross the agricultural land at Kilcrea and terminate at Newbridge Demesne, Donabate.
