Heritage Ireland 2030 Summit (Privacy Statement)

The Department of Housing, Local Government and Heritage is the Government Department responsible for housing and water, for physical and spatial planning, for local government, for weather forecasting and for built and natural heritage.

The Department is committed to protecting and respecting your privacy. This privacy statement explains how the Department, as the Data Controller, will process the personal data provided to it in respect of registration for, and attendance at, the Heritage Ireland 2030 Summit; how that information will be used, and what rights you may exercise in relation to your personal data.

Categories of personal data

The Department processes the following personal data in respect of registration for, and attendance at, the Heritage Ireland 2030 Summit:

- email address
- first name
- surname
- job title (optional)
- company (optional)
- image (a photographer and videographer will be present to record the event and this event will also be live streamed, anyone attending in person may be on camera and streamed online).

Purposes of the processing

The Department will use the information provided in order to facilitate attendance at the Heritage Ireland 2030 Summit, either online or in person, and to promote the event through photography and online streaming.

Profiling

The Department will not use any personal data collected from you in respect of the Heritage Ireland 2030 Summit for automated decision-making, or for profiling purposes.

Lawfulness of processing

This processing of your personal data is lawful under Article 6 (1) (a):

6 (1) 'Processing shall be lawful only if and to the extent that at least one of the following applies:

(a) the data subject has given consent to the processing of his or her personal data for one or more specific purposes.'

Your consent can be withdrawn at any time by emailing heritageireland2030@housing.gov.ie.

This shall not affect the lawfulness of processing based on Consent before withdrawal.

Security of your personal data

The Department implements appropriate technical and organisational measures to protect your information from unauthorised access. However, despite these efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse. In the event that your personal

data is compromised as a result of a breach of security, the Department's Breach Management policy and procedures will be implemented.

Recipients of the data

Personal data may be shared internally for audit or other compliance purposes.

Personal data may be shared with other Government Departments, local authorities, agencies under the aegis of the Department, or other public bodies, in certain circumstances where this is provided for by law.

Cross-border Data Transfers

The Department will not transfer personal data collected in respect of the Heritage Ireland 2030 Summit to any country or international organisation outside the EU/EEA.

How long will your data be kept?

The Department will only retain your personal data for as long as it is necessary for the purposes for which it was collected and processed. In line with legislative and business requirements, the data retention period for your personal data, in this instance, is 1 year after the conclusion of the Heritage Ireland 2030 Summit.

Your rights

The Department's [Data Protection Policy](#), which sets out how we will use your personal data, as well as providing information regarding your rights as a data subject (including details regarding right of access, right to rectification, right to erasure, right to restriction of processing, right to object), is available on our website. The policy is also available in hard copy upon request. If you consider that your rights have been infringed, you have the right to complain to the Irish Data Protection Commission (www.dataprotection.ie), and you have the right to seek a judicial remedy.
