I look forward to working with the NPWS, under the leadership of Niall Ó Donnchú, colleagues in Government, communities and heritage organisations, to ensure that the resources and policies are in place to implement this Strategic Plan.

Foreword from Minister Malcolm Noonan

The publication of the first National Parks and Wildlife Service Strategic Plan is a significant moment for the organisation and puts in place a coherent, ambitious Plan to improve nature and biodiversity in Ireland for the period to 2026.

When the Dáil declared a biodiversity and climate emergency in 2019, I knew that my most important task as Minister for Heritage and Electoral Reform would be to demonstrate leadership on nature and create a positive legacy for the future.

This work was started from a difficult place: the majority of our EU-protected habitats are in unfavourable conservation status with almost half declining further, a third of wild bee species are close to extinction, 60% of birds are Red- or Amber-listed, 30% of species are of inadequate or bad status, 30% of our semi-natural grasslands have been lost in the last ten years. This, in the context

of long-standing resource challenges and a need for organisational renewal, was a stark challenge.

My priority, as it has always been, is the protection, conservation and restoration of Ireland's biodiversity. To achieve this, Ireland requires a properly resourced, staffed and equipped National Parks and Wildlife Service. The Strategic Action Plan supports that objective and empowers the NPWS to play its part in our collective response to the biodiversity emergency, both at home and on the international stage. I welcome this Plan as a clear expression of how NPWS intends to drive the change required to halt and reverse the declines outlined above.

The forthcoming Nature Restoration Regulation will present further opportunities and challenges to Ireland, the NPWS and our stakeholders. The proposed Regulation provides an opportunity for transformative change in relation to achieving nature restoration in Ireland and the EU as a whole, which I strongly welcome.

Finally, and most importantly, I would like to echo Minister O'Brien's recognition of and thanks to the dedicated staff of the NPWS all across the country who have contributed so much, often under challenging circumstances, to the organisation and to nature and wildlife in Ireland. I look forward to working closely and collaboratively with the NPWS's staff and stakeholders on the implementation of this Plan.

Introduction

Ireland's National Parks and Wildlife Service has a proud history. It carries a complex range of responsibilities. These range from significant policy and advisory functions, to operational responsibilities in the National Parks and Nature Reserves, conservation, compliance, licensing, nature and biodiversity and as a statutory consultee on planning. This first Strategic Plan for the National Parks and Wildlife Service sets out the core mission and values of the NPWS, together with our key strategic priorities for 2023-2025.

The National Parks and Wildlife Service is an Executive Agency within the Department of Housing, Local Government and Heritage, with primary responsibility for nature conservation, wildlife protection and the presentation and preservation of our National Parks and Nature Reserves.

This Strategic Plan has been informed by a public consultation process. The views of members of the public and private sector organisations were heard and many of the views expressed are reflected in this Plan.

It is clear from submissions that our Parks and Nature Reserves are places of learning, reflection and recreation and are held in high esteem by those who visit them. It is clear too that the challenges facing nature are understood by our stakeholders and this Strategic Plan is reflective of that too.

The Strategic Plan also reflects the findings and recommendations of recent reviews established to advise on the structure and renewal of the organisation to ensure that it is fit for the immense challenges of protecting nature and biodiversity in the years ahead. The Strategic Plan is grounded in the new Directorate structure of the NPWS while also acknowledging the crosscutting nature of the challenges we face in delivering on our mission, which is to **Protect Nature**.

The NPWS has been sustained through decades by truly dedicated and expert people. For them, the past and current members of the NPWS team and their colleagues and our stakeholders, the 2022 'Strategic Action Plan for the Renewal of

the National Parks and Wildlife Service' represents a step-change in momentum, building on the work of many years, and the very significant gains for the organisation in recent budgets. Implementation of the Action Plan for the renewal of the NPWS is a key priority for the organisation, with the full support of Minister O'Brien, Minister of State Noonan, and Government. The endresult will be an NPWS that is more resilient. more stable, with a stronger identity of its own, better able to drive and lead change. This Strategic Plan sets a clear ambition to Protect Nature, support our staff, improve communication and it puts a much stronger focus on delivery for nature and for the public.



NPWS Management Committee

The 2022 Action Plan fundamentally changes the NPWS internal structure to six new directorates clustered around functional responsibilities:

- Scientific Advice and Research
- Nature Conservation
- National Parks and Nature Reserves
- Engagement, Corporate and Specialist Supports
- Licensing, Legislation and Guidance
- Wildlife Enforcement and Nature Protection

Each is headed up by a Director, reporting to the Director General. Collectively, the Director General and the Directors form the NPWS Management Committee.

NPWS Key Strategic Goals

Overall key strategic goals for the organisation in 2022-2025 are:

- Provide excellent scientific advice, to the NPWS, the Minister and the Government to support the protection of nature.
- Drive, support and manage excellence in nature conservation in Ireland.
- Safeguard nature and help prevent wildlife crime through enhanced supports, operations, policies, education and awareness.
- Manage our national parks and nature reserves for nature conservation as well as for education and public access for the enjoyment of nature.
- Deliver a strong, effective legislative basis for nature protection.
- Develop and deliver excellent internal and external engagement and strong corporate governance and business supports.
- Support nature protection through excellent EU and international engagement.

In developing these strategic goals, the NPWS knows that it exists in a complex environment; this includes the multiple stakeholders and operators in the wider environmental protection and enhancement arena. NPWS will collaborate and cooperate with these stakeholders. Notwithstanding the considerable time that NPWS staff currently devote to supporting cross sectoral and interdepartmental initiatives and working groups, NPWS is acutely aware of the need to further develop and deepen these relationships over the lifetime of this Plan. In addition, many environmental NGOs do invaluable work. Citizens and landowners are our country's first responders to nature, and its ultimate guardians, Organisations including the Heritage Council, the Office of Public Works (OPW), the Department of Agriculture, Food and the Marine, Department of the Environment, Climate and Communications (DECC), the Environmental Protection Agency (EPA), Uisce Éireann, the Marine Institute, Waterways Ireland, Inland Fisheries Ireland, Coillte, Bord Na Móna, An Garda Síochána,

the National Biodiversity Data Centre, the Universities and Local Authorities and Government Departments are each essential to the nature challenge.



NPWS Core Areas of Focus

- Support nature-related decision-making at all levels of Irish society through enhanced and user-friendly guidance, sharing of best practice, advice, support and enforcement.
- Foster community and societal engagement with nature and biodiversity, through effective communication, engagement and volunteerism.
- Enhance NPWS leadership, workforce excellence and build capacity.
- Expand and develop NPWS infrastructure and facilities.
- Deliver organisational transformation as set out in the NPWS Strategic Action Plan.





Scientific Advice and Research

Provision of scientific advice and evidence; centralised function for applied research and analysis within NPWS

Strategic Goals Over the Next Three Years

- Build the scientific evidence base to inform national approaches to nature conservation, protection and restoration.
- Provide the necessary scientific underpinning to fulfil obligations under the Nature Directives, to underpin site designation and to inform ongoing management.
- Provide scientific and technical inputs to assist in the delivery of the EU Biodiversity Strategy and Nature Restoration Regulation in an Irish context.
- Lead on development, evaluation and implementation of policy and strategies relating to biodiversity, including the National Biodiversity Action Plan.

Strategies

- Enhance staff resources to support the provision of appropriate and high quality scientific advice, to inform national policy.
- Collaborate with the wider research community to develop best practice approaches to nature conservation and restoration.
- Develop programmes and agreements in collaboration with research institutions and universities to support the development of scientific expertise in line with the strategic goals of the NPWS.
- Develop processes and standards for improved collection, storage, dissemination and use of scientific data.

- Optimise resourcing the Directorate by the end of 2024.
- Informed by the independent International Comparator Review, enhance, as appropriate the staffing resource over the lifetime of this Plan to meet current and future challenges.
- Publish the National Biodiversity Action
 Plan by the end of 2023, and lead on its
 delivery over the lifetime of this Plan.
- Progress a series of agreements with universities in 2023 and over the lifetime of the Plan to initiate applied and policy relevant postgraduate research.
- Publish Site Specific Conservation
 Objectives for all our Natura 2000
 sites by the end of 2024.
- Continue to fulfill all monitoring and reporting obligations required under the Nature Directives.



Nature Conservation

Conservation measures and incentives, peatlands conservation and restoration, Waterways Ireland and Shared Island/North-South capital projects

Strategic Goals Over the Next Three Years

- Implement an effective, transparent and evidence-based approach to designation of protected sites in Ireland, in accordance with national and international obligations to Protect Nature.
- Develop and roll out a comprehensive programme of conservation measures across Ireland's Natura network.
- Support initiatives to protect and safeguard Ireland's natural heritage, inside and outside designated sites.

Strategies

- Develop and implement an effective system to link conservation objectives with the necessary measures to deliver those objectives, including, where appropriate, via management plans for sites.
- Operate a significant programme of incentives and supports for conservation measures at Natura sites.
- Foster effective and trusted links with stakeholders to support more effective and collaborative approaches to nature protection.
- Develop an intuitive and user-friendly technical mechanism for the recording of information about Ireland's Natura network, including a comprehensive database of objectives and measures at Special Protection Areas and Special Areas of Conservation.

- Designations Programme to complete formal designation of existing and new Natura sites within statutory timelines.
- Engagement and Awareness -engage with landowners and communities and work to improve public awareness and support for protections at designated sites and in the wider countryside.
- Conservation Measures Programme
 to provide practical supports for
 a comprehensive programme of
 conservation measures at Natura sites.



National Parks and Nature Reserves

Operational management of our National Parks and Nature Reserves including visitors, facilities and site management, while prioritising nature conservation

Strategic Goals Over the Next Three Years

- Support sustainable tourism and public access for recreational and educational needs, while ensuring the enhanced protection and preservation of the natural environments of all our National Parks and Nature Reserves.
- Ensure best practice in visitor facilities and in their maintenance and management, including in relation to interpretation, safety and accessibility.
- Deliver an education programme of excellence, consistent across all sites.
- Ensure protection of nature conservation value of parks and reserves through promotion of sustainable use and prevention of potentially adverse uses.

Strategies

- Develop National Park management plans to incorporate both visitor management and nature conservation.
- Deliver conservation management programs for habitats and species within our National Parks and Nature Reserves including incorporating actions from the National Biodiversity Plan, Species Action Plans and Threat Response Plans.
- Develop a focused education and awareness programme that is consistent across all sites.
- Facilitate a work environment that fosters excellence in standards and customer engagement.

- Implement new Management structure for National Parks by Q2 2023.
- Publish National Park management plans with full public consultation and appropriate environmental assessments and approved for final publication by Q4 2024.
- Update and develop key visitor facilities and interpretation at National Park sites.
- Approve national education and awareness programme.
- Work with colleagues to ensure appropriate professional, training and development programmes at all levels of the Agency.



Licencing, Legislation and Guidance

Ecological assessments, licensing (wildlife), legislation including Wildlife Acts, co-ordination of judicial review cases

Strategic Goals Over the Next Three Years

- Review and recast of Wildlife Act and Birds and Habitats Regulations, and associated guidance.
- Targeted approach to provision of observations and advices on ecological aspects of work and building capacity for providing ecological advices and assessments within the Department.
- Increased efficiency of licensing process, and delivery of high quality customer service in delivery of licences issued under the Wildlife Acts, EC Birds and Habitats Regulations and EC (Licensing and Inspection of Zoos) Regulations.

Strategies

- Review of existing guidance, regulations and legislation to assist in prioritising areas of legislation and or guidance to be updated.
- Delivery of assessment and advisory service on ecological issues.
- Development and roll out of e-Licensing for all wildlife licences.

- Review of regulations, delivery of Wildlife Amendment Bill 2016, commencement of wider review of Wildlife Act and Birds and Habitats Regulations.
- Establishment of Departmental Ecological Assessment Unit.
- e-Licensing to be rolled out incrementally throughout 2023, with a view to being in place for a range of licences in 2024.



Wildlife Enforcement and Nature Protection

Enforcement and site protection, wildlife crime

Strategic Goals Over the Next Three Years

- To develop policies and strategies for the prevention, detection and enforcement of breaches of international, EU and national nature legislation.
- Ensuring effective wildlife enforcement action in respect of illegal activities.
- Creating and maintaining an effective network to co-operate and co-ordinate a consistent approach to wildlife crime and nature protection.
- Increase awareness of the importance of Ireland's wildlife and habitats and the need for its protection, the impacts of wildlife crime and how to stay within the law.
- Ensure the enhanced protection of nature in nature reserves and the wider countryside for the enjoyment of all through sustainable management, accessibility and maintenance practices.

Strategies

- Provide information and guidance, schemes, operational support and training to ensure effective compliance of nature legislation.
- Strengthen relationships with other key enforcement and regulatory authorities, agencies and stakeholders and undertake review of existing protocols in place between NPWS and other organsiations.
- Develop a focused education and awareness nature protection and wildlife crime programme.
- Maintain controls in place for financial schemes and for NPWS in its role as regulator of the Enhanced Decommissioning, Rehabilitation and Restoration Scheme to support a Just Transition.
- Continued implementation of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) regulations through the CITES Management and Scientific Authorities.

- Review the existing wildlife crime (including CITES) and nature conservation priorities, assess and identify any new or emerging priorities and development of subsequent tactical responses.
- Identify and progress operational supports, training and guidance needs for wildlife crime enforcement and nature protection by Q4 2023.
- Develop a central database which records incidents of wildlife crime, as well as the details of prosecutions.
- Put in place a public portal for the reporting of wildlife crime incidences by Q4 2023.
- Review of RAPTOR protocol by Q4 2023
- Undertake a review of deterrence and on improving the enforceability of wildlife laws (ongoing).



Engagement, Corporate and Specialist Supports

Stakeholder engagement, IR, communications, secretariat to NPWS MB, ICT, Finance, Procurement advice and co-ordination

Strategic Goals Over the Next Three Years


To develop, over the period of this plan, the capacity to:


