I note that your area marked C on your plan coloured in orange has a natural stream that flows into the estuary, this is also the position where an old well stood and served the people of Malahide Town with a water source in days gone by this well is clearly marked on old maps and I include a copy for Ref marked A.

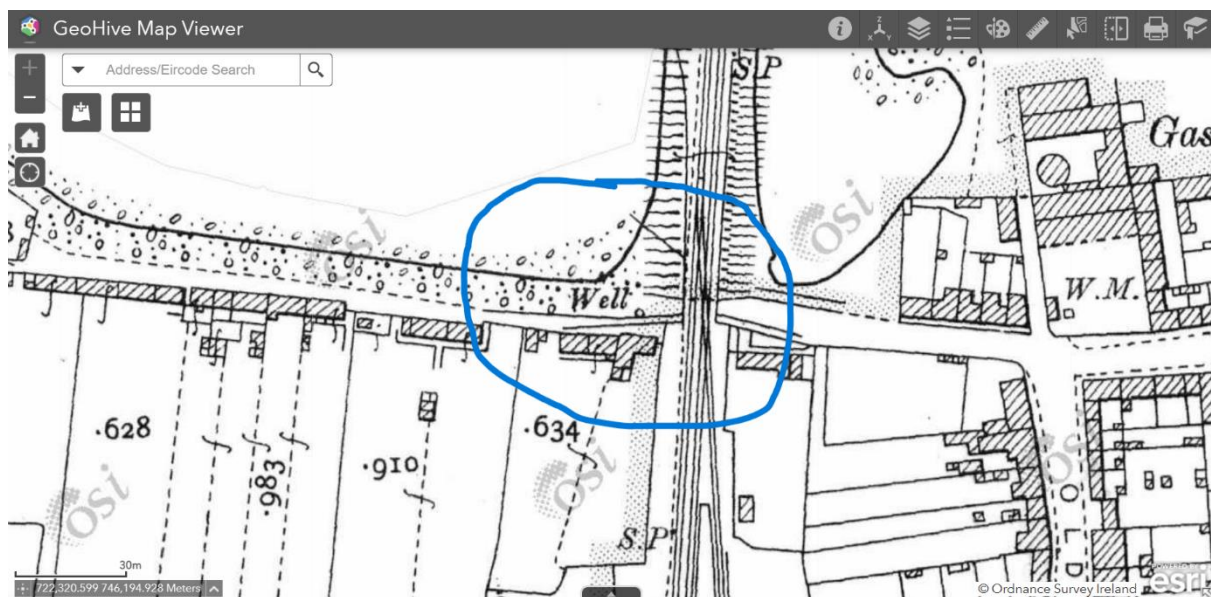

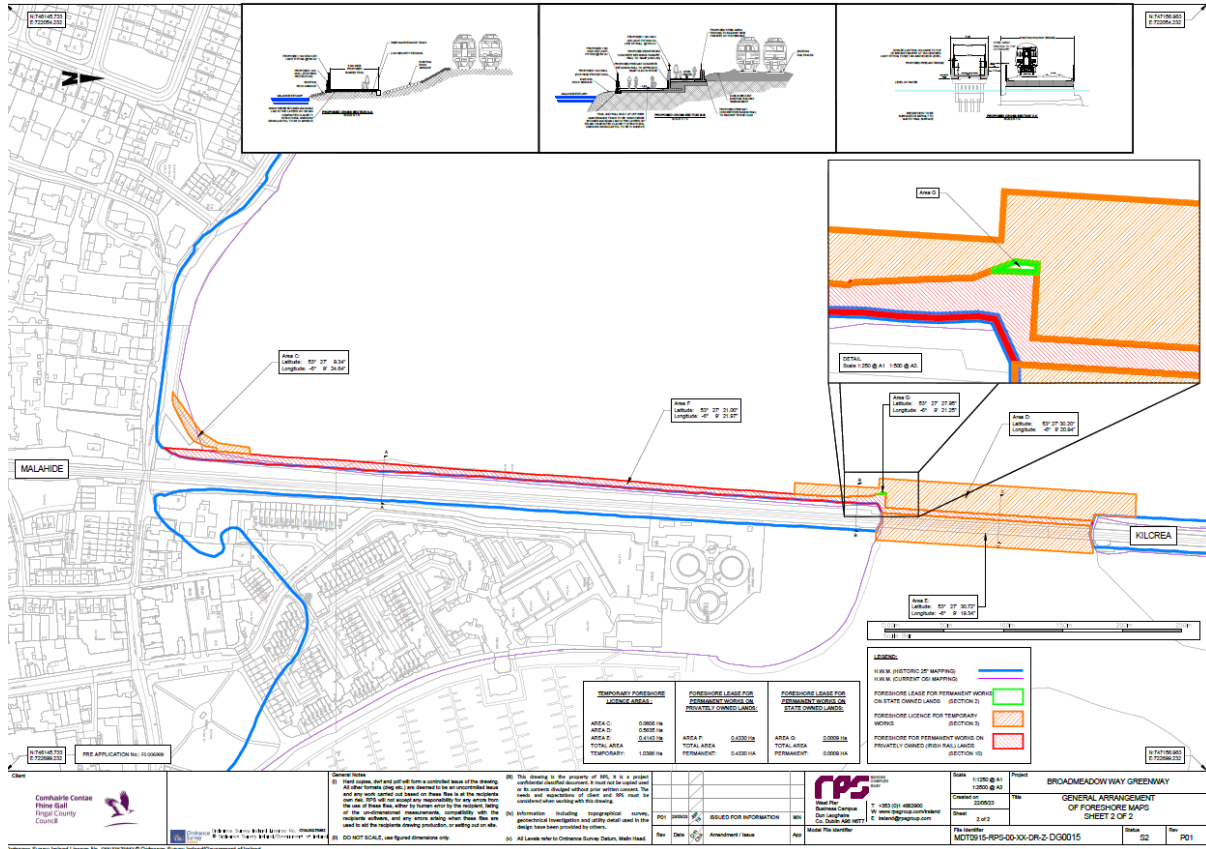
