Re: Property transfers from religious congregations as contributions towards the costs incurred by the State in responding to residential institutional child abuse.

Dear Mr Lenihan,

You will recall that I undertook to provide the Committee of Public Accounts with regular updates in regard to progress being made in completing the transfer of properties offered by religious congregations as contributions towards the costs incurred by the State in responding to residential institutional child abuse.

This letter and the accompanying tables summarise developments since my update in late 2018 and notes the current position in relation to the remaining uncompleted property transfers. The position in regard to cash contributions is also set out.

As the Committee is aware, properties are being transferred by religious congregations under two distinct rounds: the legally binding 2002 Indemnity Agreement and those offered voluntarily by congregations in 2009. Considerable progress has been made since my last report, with the transfer of six further properties being completed. There has also been extensive engagement between all of the State parties involved and with the transferring congregations and their legal representatives. Significant milestones have been achieved in the case of a number of the remaining transfers.

The position in regard to the properties offered under the two rounds is summarised below while Appendix 1 (2002 Indemnity Agreement) and Appendix 2 (2009 voluntary offers) provide further details regarding each individual property.

2002 Indemnity Agreement

Following the recent completion of three transfers (Coiscéim and Emohruo, Cappoquin, Co. Waterford and Waterpark National School, Waterford) only two properties remain to fully transfer under this round.

The Sacred Heart Centre, Waterford is with the Property Registration Authority for first registration.

In the case of Mounthawk Secondary School, Tralee, I recently met with the Congregational Leader of the Congregation of the Sisters of Mercy to discuss how the transfer could be expedited. Since that meeting there has been active engagement between the CSSO and the Congregation's legal adviser and progress has been made in addressing outstanding issues.

The position in regard to the properties concerned is set out in Appendix 1 and may be summarised as follows:

- Mounthawk secondary school, Tralee, Co. Kerry (Appendix 1 Property 1)
 Following the meeting with the Congregational leader, outstanding boundary related litigation (not involving the Minister) and associated title issues are well on the way to being resolved. However, it is not yet possible to give a definitive timeframe for the completion of the transfer.
- Sacred Heart Centre, Waterford (Appendix 1 Property 3)
 This property has transferred but a first registration is required with the Property Registration Authority.

It should be noted that in the case of the two properties referred to above, the intended recipient is in occupation of the property and providing services from it. The material relevance of the transfer process in these cases is to provide legal ratification of the existing situation where the State is already benefiting from the use of the properties.

2009 voluntary offers

Of the 18 properties offered voluntarily in 2009 and accepted for transfer to State bodies, 12 have fully transferred. Considerable progress has been made in relation to the transfer of most of the remaining properties. The position in regard to the properties concerned is set out in Appendix 2 and is summarised below.

Transfers completed since last update

- 1. St. Bernard's Group Home, Fethard, Co. Tipperary (Appendix 2 Property 10)
- 2. McAuley Centre, Kells, Co. Meath (Appendix 2 Property 11)
- 3. Adult Education Centre, Waterford (Appendix 2 Property 12)

The transfers have yet to be registered and the properties valued.

Transfers yet to complete

- (a) Consent of the Charities Regulatory Authority provided
 - Former primary school Westport, Co. Mayo (Appendix 2 Property 17).
- (b) Ministerial consents provided

- Land at Cahir, Co. Tipperary (Appendix 2 Property 13)
- Former school Ballyjamesduff, Co. Cavan (Appendix 2 Property 14).

(c) Remaining properties

- The National Rehabilitation Hospital, Dún Laoghaire, Co. Dublin (Appendix 2 Property 15)
- Blaithín, Gracepark Road, Dublin 9, (Appendix 2 Property 16)
- St Anne's Lenaboy, Galway (Appendix 2 Property 18)

The transfer of the National Rehabilitation Hospital, Dún Laoghaire and St Anne's, Lenaboy, Galway are progressing. In the case of Blaithín, Gracepark Road, Drumcondra, I have written to the congregation in relation to the delay in transferring this property and I will be meeting them later this month.

There has been further dialogue with the Congregation of Christian Brothers in relation to the proposed transfer of its playing fields.

Cash contributions

I would also like to advise the Committee of the position in regard to cash contributions offered by the congregations on a voluntary basis in 2009. A recent contribution of \in 2 million from the Congregation of Christian Brothers has brought to \in 105 million the total amount contributed by congregations, comprising contributions of some \in 103.6 million plus added interest of \in 1.382 million. These amounts have been received by the Department and placed in an investment account established by the National Treasury Management Agency. This funding is available to Caranua (the Residential Institutions Statutory Fund). A further \in 6.4 million in cash contributions is required to achieve the maximum amount of contributions of \in 110 million set down in statute that may be made available to Caranua.

A contribution of €6.8 million, being the balance of the cash contribution of the Congregation of Christian Brothers, is expected to be received over the coming months. The Congregation have informed me that these funds will be remitted upon the completion of the sale of lands at Clonkeen in Dublin: the transaction is currently in process. The amount of that contribution that is in excess of the statutory cap of €110 million, will go towards the National Children's Hospital as provided for in section 43 of the Residential Institutions Statutory Fund Act 2012 as will any additional cash contributions.

I will continue to provide the Committee with regular updates on these property transfers.
