Agri-Food Sector Contribution to the Economy

The agri-food sector contributed **7.5% of GNI*** in 2018. The sector employs approximately **164,400 people**, representing **7.1%** of total employment.

Irish exports of agricultural products accounted for 9.5% of total merchandising exports, and 11% of imports in 2019

Agri-food sector exports have **grown by 63%** since 2010 to approximately €14.5 billion, in 2019.
